



Figure 1. Typical Output Characteristics




Figure 3. Typical Saturation Voltage Characteritics





Figure 5. Saturation Voltage vs. Case




Figure 4. Transfer Characteristics





Figure 6. Saturation Voltage vs. VgE

Figure 7. Saturation Voltage vs. VgE




Figure 9. Gate Charge Characteristics




Figure 11. Turn-On Characteristics vs Gate Resistance




Figure 8. Capacitance Characteristics




Figure 10. SOA Characteeristics





Figure 12. Turn-off Characteristics vs.

Figure 13. Turn-on Characteristics VS. Collector Current




Figure 14.Turn-off Characteristics VS.
Collector Current




Figure 15. Switching Loss VS. Gate Resistance




Figure 16. Switching Loss VS. Collector Current




Figure 17. Turn off Switching SOA Characteristics




Figure 18. Forward Characteristics






Figure 19. Transient Thermal Impedance of IGBT
