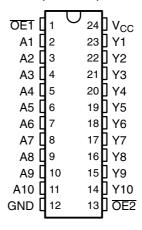
### description

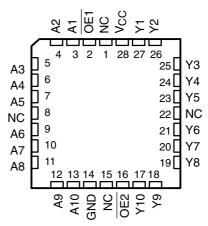

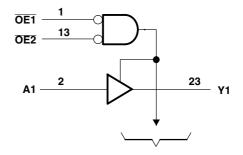

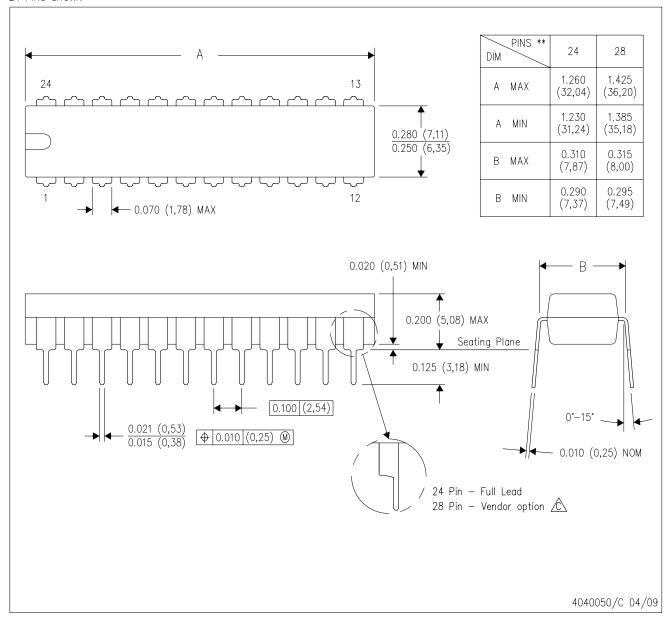
